

Ted Haynes

Ted Haynes was named the ninth leader in the 76-year history of Blue Cross and Blue Shield of Oklahoma in July 2012, accepting the position of President.

Previously, Mr. Haynes served as Vice President of Health Care Delivery at Blue Cross and Blue Shield of Texas (BCBSTX) with overall responsibility for health care delivery, including health care provider networks, provider services, pharmacy programs, and Medicaid operations. Mr. Haynes served as vice president network management since 2002, and, prior to that, as vice president and chief operating officer of the corporation's Southeast Texas region, and as chief executive officer of HMO Blue®, Southwest Texas.

Prior to joining BCBSTX, Mr. Haynes served as president and CEO of West Virginia Accountable Health Plan, a hospital organization and partner in another health plan in West Virginia, for which Mr. Haynes was chairman of the board.

Mr. Haynes' previous managed care experience was in the Houston area and included serving as director of managed care at Memorial Hermann Healthcare System; vice president/director of operations and finance for Memorial Hermann Health Network, Inc.; and senior manager/director of managed care at KPMG Peat Marwick. Mr. Haynes is a certified public accountant and began his career at Arthur Andersen & Co.

Mr. Haynes was appointed by the Governor of Oklahoma to the board of Commissioners of the Oklahoma Physician Manpower Training Commission and the Health Workforce Subcommittee of the Governor's Council on Workforce and Economic Development. He is the 2016 Chairman of the Tulsa Area United Way and Oklahoma State Chamber of Commerce. He is a member of the Board of Directors of the Oklahoma Center for Community and Justice, Tulsa Regional Chamber of Commerce and the Research Institute for Economic Development. He is also a member of the American College of Healthcare Executives, American and Texas Societies of CPAs, and the Association for Conflict Resolution.

Mr. Haynes is a graduate of Stephen F. Austin State University and has earned a masters degree in Dispute Resolution and Conflict Management at Southern Methodist University.
